



Provincial Prescription Drug Program Registration

Receive the maximum drug coverage

If you live in **British Columbia, Manitoba** or **Saskatchewan**, your provincial government offers a pharmacare program to support prescription drug costs. To maintain coverage under your Equitable Life drug plan, please register for your provincial pharmacare program.

Once you've registered, please send us a copy of your proof of registration letter one of the following ways:

If you are eligible for your provincial pharmacare program, please follow the steps below to register with your province.

1. Click on the Pharmacare Registration link below for your respective province and follow the steps to register.
2. Once you've registered with your province, please provide proof of registration using one of the three options.
3. Upload a scanned or photographed copy using our Document Submission tool. Simply log in to your online Plan Member account at www.equitablehealth.ca, click on "My Resources," select "Document Submission" from the drop-down menu and follow the instructions.
4. Or, log in to your EZClaim mobile app and click on "Document Submission".
5. Mail a copy of the letter to Equitable Life at:

If you have already provided Equitable Life with up-to-date proof of registration, you do not need to do anything.

Helpful Reminders

To make it easier to register for your provincial pharmacare program, we will send two registration reminder messages to your pharmacist, and post them on your Explanation of Benefits. Please speak to your pharmacist if you have any questions.

Once the second reminder is sent, we will decline or only partially pay your prescription drug claim.

The “First Reminder Amount” and “Second Reminder - Decline or Partial Payment Amount” are based on:

- Your age (senior 65+/non-senior); and
- Whether or not you belong to a Pay-Direct Drug Plan or a Reimbursement Drug Plan*.

Type of Plan	Age of Plan Member	First Reminder Amount	Second Reminder - Decline Amount
Pay-Direct Drug Plan	Senior 65+	\$250	\$500
	Non-senior	\$750	\$1,000
Reimbursement Drug Plan (Non-Pay-Direct)	Senior 65+	\$750	\$1,000
	Non-Senior	\$750	\$1,000

* If you belong to a Pay-Direct Drug Plan, you are provided a Benefits Card that you can present at your pharmacy when purchasing prescription drugs. You only pay the portion of your prescription cost that is not covered by your benefit plan. If you belong to a Reimbursement Drug Plan, you need to pay for your prescription at the pharmacy and submit a claim to Equitable Life for the expense.
