#### Lower correlation.

Even when the economy is struggling, consumers continue to use infrastructure for things like water, electricity, gas distribution, rail, airports, roads, and telecommunication towers. And Infrastructure has a lower correlation to other asset classes which can provide protection and minimize risk.



#### Stable cash flows/dividends.

Income-generating infrastructure assets offer cash flows underpinned by regulation or long-term contracts and not by economic conditions.



#### Inflation hedge.

Infrastructure assets act as a good hedge for inflation. Most infrastructure assets have the ability to increase prices during inflationary periods.
