The versatile fixed-income portion of the fund can invest in government and corporate debt, including high-yield bonds, convertible debt and floating-rate loans.

### Equitable Life Trimark Fund Select

**Asset Class: Global Equity**

A go-anywhere global equity fund free of any regional or market-capitalization constraints. For more than 35 years, this flagship fund has helped anchor investors' portfolios by investing in some of the most dominant business franchises around the world with a focus on absolute return while balancing capital protection with steady growth.
